14 1. The Board of Supervisors and the Registrar of Voters office are
15 requested to consent to and order the consolidation of said election with such other
16 elections as may be held Tuesday, November 3, 2026, anywhere within the territory of
17 the district.

18 2. All voting places, precincts, and election officials within the boundaries of
19 the Redbud Health Care District shall be the same as those utilized for the November
20 3, 2026, General Election.
